4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

Emergency Procedures	Keep unauthorised people away. Do not touch or walk through spilled material. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing.
Clean Up	Spills will be slippery so treat promptly. For minor spills mop up and rinse with water. For larger spills absorb material on mineral absorbent material or absorbent pads. Handling	Wear appropriate protective clothing to prevent skin and eye contact. Use in well ventilated area. Keep containers closed when not in use. Maintain a high standard of personal hygiene. Wash hands immediately after using product.
Storage	Corrosive product. Store in a cool, dry, well ventilated place out of direct sunlight. Keep only in original containers. Store in closed containers. Store away from incompatible materials such as acids, aluminium or zinc. Store locked up.

Ingestion	Swallowing can result in nausea, vomiting, diarrhoea, abdominal pain and bleeding. Can cause chemical burns to the mouth, oesophagus and gastrointestinal tract.
